TO: THE BOARD OF DIRECTORS OF NORTH AUSTIN MUNICIPAL UTILITY DISTRICT NO. 1 AND TO ALL OTHER INTERESTED PERSONS.

Notice is hereby given that the Board of Directors of North Austin Municipal Utility District No. 1 will hold a regular meeting on **Wednesday, October 15, 2008, at 6:00 p.m.**, at the District Community Center, at 7617 Elk Horn Mountain Trail, Austin, Texas, for the following purposes:

1. Consider approval of the minutes from the August 12, August 18, August 29, September 15, September 17, and September 26, 2008 meetings;
2. Receive citizens' communications;
3. Receive maintenance report from the park and landscape maintenance contractor, including approval of landscaping proposals, including renewal of contract for landscaping services;
4. Receive report regarding pool and community building project operations, repairs and construction, including approval of related proposals;
5. Receive operating report from the District's general manager, including approval of related maintenance and construction items;
6. Discuss and consider taking any necessary action regarding amendments to the District's rate order;
7. Receive a report from the District's bookkeeper and consider approval of payment for bills and invoices;
8. Discuss and consider amendment to the District's Resolution Authorizing a Manager's Account;
9. Discuss and consider approval of Management Services Agreement with Clearwater Management for services to the Community Center;
10. Receive a report from the District's engineer;
11. Consider taking any necessary action regarding MS4 Stormwater activity and turnkey implementation proposals;
12. Receive restrictive covenants report from PBF Covenant Management, LLC regarding services rendered, reporting of inspection, consider taking any necessary action on violations, including initiating litigation;
13. Such other matters as may come before the Board.

The Board of Directors is authorized by the Texas Open Meetings Act to convene in closed or executive session for certain purposes. These purposes include receiving legal advice from its attorney (Texas Government Code, §551.071); discussing real property matters (§551.072); discussing gifts and donations (§551.073), discussing personnel matters (§551.074) or discussing security personnel or devices (§551.076). If the Board of Directors determines to go into executive session on any item on this agenda, the Presiding Officer will announce that an executive session will be held and will identify the item to be discussed and provision of the Texas Open Meetings Act that authorizes the closed or executive session.
