
Notice is hereby given that the Board of Directors of North Austin Municipal Utility District No. 1 will hold a regular meeting on **Wednesday, June 24, 2009, at 6:00 p.m.**, at the District Community Center, at 7617 Elk Horn Mountain Trail, Austin, Texas, for the following purposes:

1. Consider approval of the May 18, May 20 and May 29, 2009 meeting minutes;
2. Receive citizens' communications;
3. Receive maintenance report from the park and landscape maintenance contractor, including approval of landscaping proposals;
4. Receive report regarding pool and community building project operations, repairs and construction, including approval of related proposals, pay estimates and change orders;
5. Discuss and consider taking any necessary action regarding community center, pool and tennis court complex at Rattan Creek Park and related proposals;
6. Receive a report from the District's general manager, including approval of related maintenance and construction items;
7. Discuss and consider request of Clearwire US for a lease to install wireless communication facilities;
8. Discuss and consider approval of Resolution Regarding General Manager's Account;
9. Receive a report from the District's bookkeeper and consider approval of payment for bills and invoices;
10. Consider approval of transfers between District accounts;
11. Discuss and consider taking any necessary action regarding renewal of bookkeeping services agreement with Municipal Accounts and Consulting;
12. Discuss and consider approval of revised District Registration Form and authorize filing for same;
13. Receive a report from the District's engineer;
14. Consider taking any necessary action regarding MS4 Stormwater activity and turnkey implementation proposals;

15. Discuss and consider taking any necessary action regarding renewal of restrictive covenant enforcement services agreement with PBF Covenant Management;
16. Receive restrictive covenants report from PBF Covenant Management, LLC regarding services rendered, reporting of inspection, consider taking any necessary action on violations, including initiating litigation;
17. Such other matters as may come before the Board.

**The Board of Directors is authorized by the Texas Open Meetings Act to convene in closed or executive session for certain purposes. These purposes include receiving legal advice from its attorney (Texas Gov't Code, §551.071); discussing real property matters (§551.072); discussing gifts and donations (§551.073), discussing personnel matters (§551.074) or discussing security personnel or devices (§551.076). If the Board of Directors determines to go into executive session on any item on this agenda, the Presiding Officer will announce that an executive session will be held and will identify the item to be discussed and provision of the Texas Open Meetings Act that authorizes the closed or executive session.**
