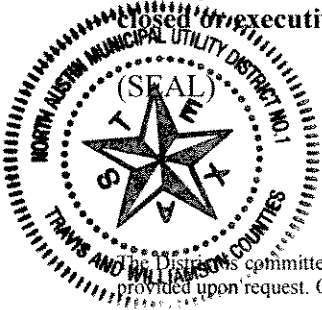

TO: THE BOARD OF DIRECTORS OF NORTH AUSTIN MUNICIPAL UTILITY DISTRICT NO. 1 AND TO ALL OTHER INTERESTED PERSONS.

Notice is hereby given that the Board of Directors of North Austin Municipal Utility District No. 1 will hold a regular meeting on **Wednesday, May 19, 2010, at 6:00 p.m.**, at the District Community Center, at 7617 Elkhorn Mountain Trail, Austin, Texas, for the following purposes:

1. Consider approval of the April 6, April 15, April 21, May 4 and May 5, 2010 meeting minutes;
2. Receive citizens' communications;
3. Discuss and consider approval of Oath(s) of Office and Statements(s) of Elected Officer for director(s) elected May 8, 2010;
4. Discuss and consider organization of officers for the Board of Directors;
5. Consider approval of revised District Registration Form and authorize filing the Form with the Texas Commission on Environmental Quality;
6. Receive maintenance report from the park and landscape maintenance contractor, including approval of landscaping proposals;
7. Receive report from the pool and community building operator and consider related proposals, including an amendment to the agreement with SDI for janitorial services;
8. Receive report from the District's general manager, including approval of related maintenance and construction items;
9. Receive report from the District's bookkeeper and consider payment for bills and invoices and transfers between accounts;
10. Receive a report from the District's engineer;
11. Receive restrictive covenants report from PBF Covenant Management, LLC regarding services rendered, reporting of inspection, consider taking action on violations, including litigation;
12. Discuss and consider taking any necessary action regarding possible agreement for restrictive covenants enforcement activities;
13. Discuss and consider taking any necessary action regarding future annexation and possible limited district conversion;
14. Discuss and consider taking any necessary action regarding playground litigation; and
15. Such other matters as may come before the Board.

The Board of Directors is authorized by the Texas Open Meetings Act to convene in closed or executive session for certain purposes. These purposes include receiving legal advice from its attorney (Texas Gov't Code, §551.071); discussing real property matters (§551.072); discussing gifts and donations (§551.073), discussing personnel matters (§551.074) or discussing security personnel or devices (§551.076). If the Board of Directors determines to go into executive session on any item on this agenda, the Presiding Officer will announce that an executive session will be held and will identify the item to be discussed and provision of the Texas Open Meetings Act that authorizes the closed or executive session.
