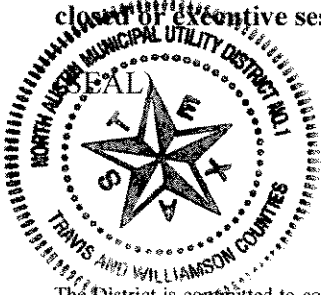

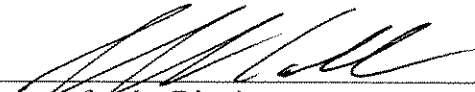
Notice is hereby given that the Board of Directors of North Austin Municipal Utility District No. 1 will hold a regular meeting on **Wednesday, July 21, 2010, at 6:00 p.m.**, at the District Community Center, at 7617 Elkhorn Mountain Trail, Austin, Texas, for the following purposes:

1. Consider approval of the June 8, June 16 and June 21, 2010 meeting minutes;
2. Receive citizens' communications;
3. Receive maintenance report from the park and landscape maintenance contractor, including approval of landscaping proposals;
4. Receive report from the pool and community building operator and consider related proposals;
5. Receive report from the District's general manager, including approval of related maintenance and construction items and tree services proposals;
6. Receive report from the District's bookkeeper and consider payment for bills and invoices and transfers between accounts;
7. Discuss and consider taking any necessary action regarding proposals for auditing services;
8. Discuss and consider taking any necessary action regarding proposals for bookkeeping services;
9. Receive a report from the District's engineer;
10. Discuss and consider approval of the following:
 - a. Rattan Creek Park Irrigation System Project – Pay Estimate No. 2;
11. Discuss and consider taking any necessary action regarding approval of a contract televising a portion of the District's wastewater lines;
12. Discuss and consider taking any necessary action regarding approval of an Order Adopting Policies for Storm Water Protection and Establishing Penalty for Violation;
13. Receive restrictive covenants report regarding services rendered, reporting of inspection, consider taking action on violations, including litigation;

14. Discuss and consider taking any necessary action regarding future annexation and possible limited district conversion;
15. Discuss and consider taking any necessary action regarding playground litigation; and
16. Such other matters as may come before the Board.

The Board of Directors is authorized by the Texas Open Meetings Act to convene in closed or executive session for certain purposes. These purposes include receiving legal advice from its attorney (Texas Gov't Code, §551.071); discussing real property matters (§551.072); discussing gifts and donations (§551.073), discussing personnel matters (§551.074) or discussing security personnel or devices (§551.076). If the Board of Directors determines to go into executive session on any item on this agenda, the Presiding Officer will announce that an executive session will be held and will identify the item to be discussed and provision of the Texas Open Meetings Act that authorizes the closed or executive session.
